The International Secretariat notes that Capricorn Energy Plc's "Code of Ethics" chapter on "Governance" addresses issues such as "Risk Management", "Relationships with Suppliers and Partners" and "Bribery and Corruption" (PDF p. 6-7). Capricorn Energy's "Sustainability Report" describes how the company's "approach to evaluating tenders includes an anti-bribery assessment, and [] conducting risk-based due diligence when selecting contractors" (PDF p. 42, 2021).
