Sibanye Stillwater's anti-corruption framework sets out how the company manages corruption risk through the identification and use of beneficial ownership data. The International Secretariat notes that Sibanye Stillwaters' policy for responsible sourcing of metals stipulates that the company must conduct enhanced
	due diligence on "Metal Supplying Counterparty or other known upstream companies or their Beneficial Owners with significant influence over the Metal Supplying Counterparty are politically exposed persons" (page 7). The International Secretariat notes the company's Anti-Money Laundering Framework and Anti-Corruption Policy are under review by its Legal Counsel.
